

Acknowledgement of Risk and Release of Liability

I am aware that there are inherent risks and hazards involved in activities with and around dogs, and I am voluntarily participating in these activities with the knowledge of these potential dangers. I am aware that any dog, regardless of training, handling, or environmental circumstance, is capable of biting and I expressly acknowledge the risks therein. In order to participate in dog training classes or other activities, I, being fully informed of such risks and hazards, agree to assume all risks of such occurrences.

In consideration of being allowed to participate in dog training provided by Minnesota Canine Consulting, LLC (MCC), related events and activities, I hereby release and forever discharge and hold harmless MCC and each of its directors, officers, successors and assigns from any and all liability, claims and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the training received from MCC. I understand and acknowledge that this Release discharges MCC from any liability or claim that the I may have against MCC with respect to any bodily injury, personal injury, illness, permanent disability, death, or property damage that may result from the services MCC has provided, whether caused by the negligence of MCC or its officers, director, employees or otherwise, to the fullest extent permitted by law.

I also agree to assume sole responsibility for injury or damage caused by myself, or by the dog I own or handle and further agree to indemnify, defend and hold MCC, its instructors, trainers, assistants and property harmless from any damage, loss, liability or expense, including legal cost and attorney's fees, which result from damage caused by myself, or by the dog I own or handle.

MCC makes no representations, guarantees, promises, implied or expressed, that any training received from MCC will cure a dog of any dangerous propensities, or reach the goals for which training was provided.

I agree that this document is a legally binding contract, and if a lawsuit is filed against MCC, or against any of its directors, officers, employees, or agents, that I will pay all attorneys' fees and costs incurred, in defending such claims, actions and/or lawsuits.

MCC may use pictures and/or video of me or my dog for publicity or promotional purposes of MCC without liability or obligation of any kind to me; however no information/pictures can be sold or shared otherwise without additional consent.

I affirm and have proof that my dog is current on all vaccinations appropriate to my dog. I agree to abide by all rules presented during the training.

I HAVE READ THIS ACKNOWLEDGMENT OF RISK AND RELEASE OF LIABILITY AGREEMENT. I UNDERSTAND THAT BY SIGNING THIS DOCUMENT, I AM WAIVING VALUABLE LEGAL RIGHTS. I HAVE CONCLUDED THAT THE RISKS INVOLVED, AND THIS RELEASE OF LIABILITY IS WORTH THE TRAINING PROVIDED.
